GROWING YOUR COMMUNITY

2018 was another year demonstrating how well the alignment of donors and their funds can come together to make a great impact in their community.

Grow Your Community. In 2018 thirty-three (33) new charitable funds were established bringing the total number of charitable funds under management to 391.

Grow Your Community. Our donor base rose to 2,047 in 2018 from 1,823 the previous year. Each contribution making a difference in building stronger communities.

Grow Your Community. Valley Center did. A fouryear campaign of the Friends of Valley Center Public Library worked with our local affiliate foundation to raise more than \$511,000 as a public-private partnership that resulted in a new library and community building.

Grow Your Community. *Hesston did.* Hesston is widely known for its municipal Hesston Golf Course by both travelers and local citizens. The Mullet family took an opportunity to be a part of an effort for upgrading the course and other amenities. A \$300,000 charitable gift will help with the design of the Clubhouse, making this stop an even greater attraction for the city of Hesston.

Grow Your Community. *Our Service Region did.* The Newton Community Foundation affiliate was established in September 2018, distinguishing CKCF-Host model as the umbrella organization.

Grow Your Community. *Our Service Region did.* Building on our future, nearly \$110,000 was invested for higher education through the award of 110 scholarships. Growing our workforce through charitable giving is a priority to many of our donors as we continue to grow in this area of fund management.

Grow Your Community. Our Service Region did. Across our service region grants were awarded for the benefit of the needs of children, older adults, vulnerable populations; as well as community benefits for education, the arts and community gathering. More than \$2M in charitable grants made an impact in 2018.

There are lots of ways to Grow Your Community. Central Kansas Community Foundation is proud to be a part of numerous collaborations, not only with individual donors but institutions and government. The future is bright for our communities. Together we are growing communities with charitable support that is benefiting our members not only today but also tomorrow.








Interior of the rennovated Valley Center Library.


