Spotlight Project

In 2020 it became apparent to the citizens of Howard that the Howard City Pool would possibly be closed for the future. This group of concerned citizens decided to approach the Howard City Council and find out what could be done to keep the pool open. The Howard City Council agreed to use memorial and other funds to renovate the pool if the community would raise an additional \$20,000 to show their support of the pool project. The ECCF came alongside this group of citizens and began a campaign to raise the necessary funds. With the support of community members all over Elk County and former citizens, the necessary funds were raised! The ECCF presented a check to the Howard City Council for \$14,350 which along with funds that were collected in the Howard City Office met the \$20,000 goal. The ECCF continues to hold and collect additional funds for the future needs of the pool. The pool opened for its first full summer season in May 2022. Citizens of Elk County were invited to sponsor a free swim event during the pool season and ECCF sponsored two swims during the summer of 2022.

My Friend, Margery Cunningham

I met Margery when I first moved to Howard twenty years ago.

She and I were talking at the Elk River Festival about our love of walking. Since that time, I have come to know and love so much more about Margery and our common interests. One day several years ago, she knocked on my front door holding an envelope containing money. She asked if I would help start a scholarship fund honoring her two sons, Jimmie, and Steve, who had passed away. Margery was a nurse and wanted to help others become nurses. She told me a heartwarming story about when she was a single mother of five and in nursing school. During this challenging time, someone noticed she needed new tires on her car and generously offered money to replace them. She never forgot that much needed gift and wanted to pay it forward

while also honoring her two sons.

A few years ago, I had another wonderful conversation with Margery. She told me she received a phone call from someone who owed her son, Jimmie, money after borrowing it 30 years ago. Prior to Jimmie's passing, this friend did not have the chance to repay him. Jimmie had told him to give the money to Margery if he ever wanted to pay it back. Apparently, he had come into some money, remembered the debt and Jimmie's instructions. He called Margery and she was amazed that he was repaying a 30-year-old debt that only he knew about. She asked me to reach out to Jimmie's friend and see if he would donate the money to the nursing school scholarship fund established in her sons' memory. We have since added this generous financial donation to the fund, so that it can be endowed and continue to help Elk County nursing students for years to come.

It's important to note that Margery Cunningham is 97 years old and currently lives with her son in Oklahoma. She lives very frugally on social security. And yet she generously developed a substantial scholarship fund to help others. Think of what the rest of us could do if we tried to pay it forward and manage our gratefulness as lovingly as Margery!
