#### Reviewer Role

As a volunteer reviewer, your role is to read and score applications for grants or scholarships. Each fund within a cycle has its own unique criteria. By serving as a reviewer, you help advance the mission of Central Kansas Community Foundation (CKCF) and our affiliates—supporting students and nonprofits across our service area.

Reviews are completed online through our application platform, typically within a 10 to 14 day window. **Once assigned**, you will receive login details, instructions, and deadlines for that cycle. CKCF Program Officers are your main contacts for support and guidance.

## Shared Expectations for All Reviewers

- Confidentiality: Never share application details outside the review process.
- Conflict of Interest: Disclose any personal or professional connection to an applicant. If conflicts arise, you may be excused from that application or cycle and reassigned later.
- Fairness: Score only on the information provided—do not rely on assumptions or personal familiarity. This ensures an objective and unbiased review.
- Professionalism: Treat all applications with equal care and respect.

## **Important Notes**

- A desktop or laptop is required. Supported browsers: Google Chrome or Firefox (not Internet Explorer or mobile devices).
- Applications are scored using a rubric (generally 1–5 scale) to ensure fairness and consistency.
- Reviewer comments are kept anonymous and may be summarized for committee discussion.
- Applications must be marked 100% complete—remember to click Save.
- All financial information submitted by applicants is strictly confidential.
- Completion of the compliance packet is required before assignment. Once complete, a Program Officer will invite you to serve on a review committee throughout theyear.
- If you accept an assignment, you must adhere to the provided timeline and submit scores by the deadline. Timely participation ensures a fair and efficient process.
