Assets transferred this way pass tax-free to the Foundation and may also reduce your taxable estate.

A GIFT FROM YOUR IRA

Use your IRA to make a tax-smart gift now and in the future to FCF. Donors over 73 can directly transfer annual gifts from their IRA to FCF. This Qualified Charitable Distribution isn't counted as taxable income and can fulfill your Required Minimum Distribution for the year. Contact your IRA administrator to facilitate this direct gift.
